4. All NEFT / RTGS to be made in favour of "**FKCCI**"
5. FKCCI MSME Conclave - 2024 reserves its right to change the floor plan and the location of the exhibitor's stall. If possible, exhibitors will be stationed as per his / her original booking or equivalent thereof.
6. FKCCI MSME Conclave - 2024 will make appropriate security arrangements.
